DISCUSSION ITEMS

1. Budget

Director Larsen provided brief update on City of Tacoma budget process and Tacoma Public Library's potential 2021-22 budget impacts.

NEW BUSINESS

RESOLUTION 20063: Be it resolved that the Board approves the revised Grooming and Attire Policy (formerly the Dress Code Policy). The updated policy gives staff more autonomy in their work attire dress and acknowledges TPL's value system in regards to equity and the acceptance of all body types and cultural/religious dress.

Motion was moved, seconded, and passed.

Discussion: Board requested staff add the language "Prohibited language and images not permitted in any form" to the dress-code policy.

RESOLUTION 20064: Be it resolved that the Board authorizes Library staff to revise Management Services Policy #23.00 to allow use of City of Tacoma contracts, cooperative purchase agreements, and its Architectural & Engineering (A&E) roster. This will allow staff access to numerous competitive, pre-negotiated contracts for various goods and services regularly utilized by the Library system, and will better take advantage of the City's purchasing division's expertise and resources. Approval to use the A&E roster will streamline smaller capital improvement projects by allowing staff to select from a curated list of pre-qualified firms. Selection of a firm from the A&E Roster is intended to satisfy the quote and bid requirements of the formal and informal buying procedures.

Motion was moved, seconded, and passed.

RESULUTION 20065: Be it resolved that the Board authorizes Library staff to issue a Request for Proposal (RFP) for managed leased lit fiber with internet access. **Motion was moved, seconded, and passed.**

DIRECTOR'S REPORT BUDGET UPDATE

- Thanks to the Library Board, Community, and Staff for all of the ways they participated in the budget information campaign
- \$1.2M is the new proposed reduction
- We will not know the outcome until City Council votes next Tuesday evening, Nov. 24
- Labor negotiations were based on the assumption that the revised proposal will pass; We remain hopeful we can avoid significant job loss
- Two week furloughs (per year) are likely

SERVICES IMPACT REPORT

- TPL experienced their first positive COVID19 case at Kobetich Branch this month
- Governor's latest guidance made no changes to library operations
- Main Library 2nd Floor transformation
 - Director currently meeting with local non-profits as potential partners to utilize the 2nd floor Main Branch Space
- All staff and branches have new phone numbers phone numbers are updated on the website and were sent to the Library Board of Trustees via email

DATA TRACKING: BLOOMBERG HARVARD CITY LEADERSHIP INITIATIVE

- Library is collaborating with Mayor's office to participate in an opportunity that will aid the library in formalizing how library data is tracked as it relates to the strategic plan
- A data and implementation support team will engage with the library over the next several months to help improve data quality or collection processes, analyze data, and use it to inform day-to-day management, as well as policy development and community outreach

- Mayor Woodards hosting a conversation with author of *Children of the Land*, Marcerlo Hernandez Castillo at 6pm on January 9th (virtual event)
- Youth service to host a conversation and reading with poets Yosimar Reyes and Jose Olivarez; and a performance by Seattle Hip-Hop Artist Lucid (virtual event)

TRUSTEES REPORT

- Donna LaFrance Gave staff kudos on a recent newsletter publication and a news article on the tool library collaboration
 - Requested clarification on security measures being implemented to protect the property of non-profit partners moving on to the second floor of the Main Branch. Director Larsen gave additional details on current security measures for the Main Branch Library.
- Joseph Colón Advised staff that he spoke to the leadership team of Write 253 and they are excited about a potential partnership with the Library
